# Revision in Fee Structure for Academic Session 2021-22 as per G.O. dt. 12.08.2021

Dear Parents, 13.08.2021

The Government of Maharashtra vide their order (G.O.) dt. 12.08.2021 has asked schools to offer a reduction of 15% in the overall fees for the Academic year 2021-22 as a one-time measure in view of COVID-19. Please note the following changes in the fee structure:

#### 2) Important Points with respect to Payment of Fees:

- a) Please note that there will be no hike in Annual fees. The fees structure for 2019-20 is in force. The 13% fee hike approved by **EC-PTA 2019-20** for academic 2020-21 will now be implemented for the Academic year 2022-23.
- b) There are no changes in the fee payable amount for Grades 1 to 4 as the School Management has already offered a 15 % rebate for these classes in line with the requirement of the G.O.
- c) For Grades 5-9, the rebate offered by the School Management was 5%, which is now increased to 15%. The same has been adjusted in the Fee Payable amount for the Second Term
- d) For Grade 10-12, no rebate was offered by the School Management for the current academic year. 15 % is now applicable. The same has been adjusted in the Fee payable amount for the Second Term
- e) Please note that there are no changes Fee payable amount for 1st Term.
- f) Parents of Students in Grades 2 to 12 may now if they so wish pay the Full Year's Fee
- g) Parents are requested to note that, the G.O. requires the 15% rebate to be offered only for the Academic Session 2021-22. However, the School Management had offered it for the previous academic session (2020-21) as well without there being any extant legal requirement to do so.
- h) In case you have paid any excess fee in the year 2020-21 due to the application of rebate last year, you are requested to contact the Accounts office (aartichandak.ncsacc@gmail.com) to find out the adjusted fee amount for Academic Session 2021-22
- i) This circular does not apply to students already availing other fee concessions.

## 3) Adjustment/Refund of Excess Fee paid for the Academic Session 2021-22

- a) For Parents of Grades 5-9 and 11, in case you have remitted the complete fees for the current session as per the old structure, the excess fee paid will be adjusted against your fee dues for the Academic session 2022-23
- b) For Parents of Grades 10 and 12, in case you have remitted the complete fees for the current session as per the old structure, the excess fee paid will be refunded by 31.03.2022
- c) For Parents of all Grades who wish to apply for Transfer Certificates (T.C.) of their wards during the year or at the end of the current session and have paid the full fees as per the old structure, the excess fee paid will be refunded within a month of the application for T.C.
